## BERMUDA FOREIGN OPERATOR PERMIT APPLICATION FORM

#### **INSTRUCTIONS**

- All aircraft operating commercially to and from Bermuda require a Foreign Operator Permit (FOP) unless Bermuda or UK registered. See the additional information section for details and exceptions.
- Applications must be submitted with supporting documentation via E-mail to: ForeignOperatorPermit@bcaa.bm
- 48 hours' notice is normally required for FOP issuance.
- Any requests for Permits at short notice must be discussed with the Issuing Officer and receive email approval/confirmation prior to operations.
- Last-minute aircraft changes due to unforeseen circumstances are permitted, provided that all required aircraft documents (and licences of any flight crew changes) have been submitted to BCAA before the flight is conducted.
- Operational date change for single flights is permitted within three (3) days of the initial proposed date without the need to reapply for permission.
- Operators and pilots must refer to the <u>Bermuda Aeronautical Information Publication (AIP)</u> for important operational information and requirements for Bermuda and the surrounding airspace.
- In accordance with ICAO Annex 1 Standard, the operating flight crew <u>must not have attained the age of 65</u>
  years on the date of the intended flight.

# THE FOLLOWING DOCUMENTS MUST BE PROVIDED WITH THE APPLICATION FOR ALL AIRCRAFT:

- Operating Licence, Air Operator Certificate or Air Carrier Certificate
- > Ops Specs which detail approval to operate in RNP and RVSM Airspace (\*\*only these Ops Specs required\*\*)
- Certificate of Registration
- Certificate of Airworthiness
- Noise Certificate
- Operating flight crew pilot licences (A copy of each operating pilot's licence to be provided, showing the date of birth, type rating, and valid medical certificate)
- Certificate of Insurance

## I/We hereby confirm that:

- 1. The Operator will comply with Article 105 of the <u>AN(OT)O 2013</u>, as amended, regarding Aerodrome Operating Minima and the requirements of OTAR 91.235 and 91.240.

#### **ADDITIONAL INFORMATION:**

1. Any aircraft that is not registered in Bermuda, the United Kingdom, or any other U.K. Overseas Territories that takes on or sets down passengers or cargo in Bermuda, if valuable consideration (payment) is given or promised in respect of such carriage of persons or cargo, requires Governor's Permission under <a href="Article 135 of the AN(OT)O 2013">Article 135 of the AN(OT)O 2013</a>, as amended.

This will apply to the following types of flights:

- FAR Part 135 Operations
- A.O.C. or Air Carrier Operations (non-scheduled and charter)
- FAR Part 91K (Fractional Operations)
- Air Ambulance Operations (required but no charge will be levied)

#### This will **NOT** apply to:

- FAR Part 91 Operations
- Private flights (e.g., EASA Part NCC)
- Humanitarian Flights
- Pre-approved Military Operations
- State Aircraft
- Overflights and Technical enroute landings (e.g., refueling)
- 2. With effect from 1<sup>st</sup> April 2021, the following charges will apply to the granting of Governor's Permission to conduct Commercial Air Transport into and out of Bermuda. The following charges are in accordance with Part 4 of the Air Navigation (Fees for Certificates and Services) Regulations 2022.
  - a) For the granting of a single flight permit \$500.00
  - b) For the granting of six month's (unlimited visits) for a single aircraft \$2,000.00
  - c) For the granting of six month's (unlimited visits) for up to ten listed aircraft \$5,000.00
  - d) For an amendment to the listed aircraft (per single addition or substitution) on an issued foreign operator permit, \$250.00
