**RUSSIAN AIRSPACE
NOTAM FOR BERMUDA REGISTERED
AIRCRAFT**



1 INTRODUCTION

- 1.1 This Ops notice is issued to draw the attention of operators to the Russian NOTAM found in their [AIP \(caiga.ru\)](http://caiga.ru). The NOTAM states that it is a response measure to the restrictions listed within a Bermuda NOTAM. The NOTAM promulgated in Bermuda (ICAO: TXKF) can be found at [Federal Aviation Administration: NOTAM Search \(faa.gov\)](http://FederalAviationAdministration.gov).

2 INSTRUCTIONS

- 2.1 In summary, the below NOTAM restricts any operation of aircraft owned, chartered, or operated by a person connected with Bermuda or Registered with Bermuda into Russian airspace without express permission by the Russian Federal Air Transport Agency.
